 - 1. Amber reported that she has had to answer questions from the collection company, explaining that it's a city ordinance for those who have been arguing the charges.

b. General Reports

- DNCA approved their new bylaws. After BID bylaws are approved, the BID will be the board for both entities. All but one of the DNCA members will step down, and one would like to join the BID.
- ii. We are looking toward a 3-4 hour workshop in early 2025 to merge the two organizations.

(3) Old Business

- a. Snow removal
 - Discussion: the businesses are liable for falls; certain vacant buildings don't clear snow; some businesses are closed on certain days; it's a good perceived value for BID members.
 - ii. We will need to set policies for when and how to clear snow: automatic minimum 2", needs to be done early in the AM, push to corner or into one parking space, goal

is to create safe paths, not clear all snow, mid-day snow should be addressed by business owners. Communication should go out to all business owners.

- b. Scope of work for social media manager
 - Discussion: Point of contact has been Robyn Sellers needs to be clear; new business intro videos have been good; Clayton's list (to be added here); need to include farmer's market events; set policy for social media responses
- c. Beautification and Special Projects discussion
 - i. Fixtures: benches, trash cans, flowerpots, public art, bike racks, ash trays
 - ii. Relocate: bike racks that are in a parking space
 - iii. Need to establish committees to address specifics

(4) New Business

- a. Action Item: Approve amended FY25 budget
 - i. Discussion: Fiscal year (October September) expected earnings is \$124,000+ based on new policies, but we will only collect 3 quarters at that rate. \$10,000 in receivables have been submitted to collections. We have \$64,000+ already in the account from current collections.
 - ii. Discussion: We will invite our accountant to the January meeting to give instructions on budgeting between two organizations.
